## **TRANSFERS Section 16a. Transfers (formerly Move-ups).**

After a dog earns a title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed. A transfer (from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Movement between an "A" and "B" class at the same level is not considered a transfer. Refer to Entry of Ineligible Dog, Section 16b.

## **ENTRY OF INELIGIBLE DOG Section 16b**

A dog which has been entered in an "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the "B" class at the same level under the following condition: 1) The request for the move must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. 2) The request must state the reason and justification for the move from an "A" class to the "B" class within the level.

## **Opening Date for entries is Wednesday, August 15, 2019 at 9:00 am CST.**

Entries received prior to the opening date will be returned. Closing Date for entries is Wednesday, September 25, 2019 at 10:00 pm CST.

**Limits** - Entries are limited to 50 Rally entries each trial; Entries in all obedience classes offered are unlimited. Entries will automatically close when limits have been reached, even if it occurs before the official closing date. A wait list will be kept for entries received after limits are reached.

This show is comprised of 4 trials, with one obedience and one rally trial each day. If a dog is entered in both Obedience and Rally on the same day, you must pay the fee for the first entry of the dog in EACH trial, as they are separate events.

Dogs will be arranged in jump height order “small to tall” for Rally and Obedience, both days. Please include your jump heights on the entry form.

# NOTICE TO EXHIBITORS

- \*Rabies Alert\* The State of Texas is under a state-wide rabies quarantine. Proof of current vaccination may be required.
- \*\*There is limited crating space\*\*. The Club realizes that large crates, 300's, 400's or larger are extremely heavy and difficult to transport. However, it is important that anyone who can bring a stackable crate do so. Please stack crates wherever possible. No X-pens or lounge chairs.
- Please keep walking aisles open.\*
- Facility will be available to exhibitors for setting up crates on **Friday evening** from 5:30- 7:00 pm.
- Bring your own "small" chairs.
- There is limited parking space.
- Exhibitors must pick up after their dogs anywhere on the show site which includes area outside the fence or by the ditches.
- A designated warm-up area (practice ring) shall be provided outdoors. The AKC has charged Trial giving clubs the responsibility to enforce the Rules and Regulations forbidding drilling and/or unacceptable training on the trial grounds.
- No spiked or other special training collars. Drilling, intensive, or abusive training will not be allowed.
- Entries not on official AKC entry form and/or entry forms without Agreement and Rules attached are not acceptable. Entries will not be accepted without signature, fees and back of entry form. Entries may be faxed and entries paid via PayPal. (see entry fees). **Entries will not be accepted prior to the opening date/time. Entries received prior to the opening date will be returned.**
- Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries will not be accepted.
- Returned checks and/or declined credit cards do not constitute a valid entry. A \$25 service fee will be added for all returned checks or declined credit cards. All entries must be paid in full prior to showing.
- Bitches in season and sick dogs are NOT permitted on the show grounds. The HOT Dog Club will refund all but a \$5 processing fee, per trial, for bitches that come into season after the closing date or dogs that are too ill to show after the closing date. The Trial Secretary must receive written certification from a veterinarian's office no later than 30 minutes before the start of the first class of the trial in order to receive a refund.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee
- The safety of the dogs and exhibitors is our primary concern. By entering this Trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that they and their dogs are familiar with and able to perform all obstacles safely.
- All dogs present must be on leash or confined to crates when not being judged except when in the designated warm-up area.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the site. In such case, no refund of any entry fees will be made.
- Members and Officers, including the Trial Secretary of the HOT Dog Club, may enter dogs at these trials.
- The HOT Dog Club assumes no responsibility for any loss, damage or injury sustained by exhibitors or handlers or to any of their dogs or property and further assumes no responsibility for injury to children.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The Judge need not wait for any dog holding up a class; nor will HOT Dog Club nor the Trial Secretary be obligated to furnish any service to notify exhibitors/agents of class judging.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list.
